### 3. **Users Rights**

### 5. **Using Your Information**

- i. You were interested in details of properties we are offering, when we will continue to hold your information in order to send you information on other properties that may interest you;
- ii. You become a client or a buyer of a property;
- iii. You require us to retain it for longer; iv. We are required to retain it for longer for other legal reasons.

You have the right to withdraw your consent to us using your data and to request that we delete it.

We will not share any of your data with any third parties for any purposes unless we obtain your prior consent.

## 6. **Storage of your Data**

Your data will only be stored in the UK.
